**WILLIAM TURN MEETING OVER TO KOZER.**

**KOZER STATED FIRST WE WILL DISCUSS ITEM #3; THE PESBA (PUBLIC EMPLOYEE BENEFIT SAFETY ACT) #9 CASE. THE PESBA STATES THAT IF YOU ARE A FIRE FIGHTER OR A POLICE OFFICER THAT IS INSURED IN LINE OF DUTY; THAT THE CITY WOULD PAY FOR YOUR INSURANCE UNTIL YOU ARE OF MEDICARE AGE. WE HAVE A FILE OF PESBA CASE #9 WHICH THE EMPLOYEE CAN OBTAIN HIS INSURANCE THROUGH HIS SPOUSE. EVERY YEAR WE HAVE THEM FILL OUT FORMS AND THE INSURANCE DID GO UP FROM \$380.56 TO \$409.12 A MONTH. WE WILL PAY THE NEW MONTHLY I AM JUST INFORMING THE COMMITTEE OF THIS; IT IS ACTUALLY CHEAPER THAT IF HE WASN'T ON THE CITY PLAN. KOZER STATED STARTING NEXT MONTH I WILL REVISE THE WAY WE HANDLE THE MONTHLY REPORT. WE CURRENTLY HAVE 40 CASES OPEN RIGHT NOW. THE REPORT WILL HAVE WHAT THE CASE IS; WHAT STAGE IT IS; AND THE AMOUNT OF MONEY SPENT ON THE CASE. SO EVERY MONTH YOU WILL HAVE A SNAP SHOT OF WHAT IS HAPPENING WITH ALL THE CASE. ALSO NEXT MONTH WE WILL TALK ABOUT ALL THE INSURANCE COVERAGE THAT THE CITY HAS. KOZER EXPLAINED THE DIFFERENT TYPES OF CASES AND THE WAY THEY ARE HANDLED.**
